FINANCIAL PERFORMANCE AND ANALYSIS

- During the quarter ended December 31, 2017, RIIL achieved Total Revenue of ₹ 2,571 lakh as compared to ₹ 2,380 Lakh in the previous quarter of 2017-18.
- During the Nine months ended December 31, 2017, RIIL achieved Total Revenue of ₹7,433 lakh as compared to ₹7,793 Lakh in the corresponding period of 2016-17.
- During the Nine months ended December 31, 2017:
 - Income from Product Transportation Service increased from ₹ 1,927 lakh to ₹ 2,248
 Lakh on Y-o-Y basis.





- o Income from Hiring Construction Machineries decreased from ₹ 2,637 lakh to ₹ 1,867 lakh on Y-o-Y basis.
- Income from Other Support Services increased from ₹ 2,373 Lakh to ₹ 2,408 lakh on Y-o-Y basis.

Net Profit during the Nine months ended December 31, 2017 was ₹ 720 Lakh as compared to ₹ 912 Lakh in the corresponding period of 2016-17.

RIIL continues to provide infrastructure support services namely transportation of petroleum products and water through pipelines, construction machinery on hire, and other support services to Reliance Industries Group, with a substantial portion provided to Reliance Industries Limited.

RIIL presently does not have any expansion plans on the anvil.
